## **Qualifying Holding in CTT**

CTT – Correios de Portugal, S.A. ("CTT") hereby informs, under the terms and for the purposes of article 17 of the Portuguese Securities Code that it has received on 10 April 2015 from F&C Management Limited a communication of a qualifying holding as follows:

## "Acquisition of a qualified shareholding in CTT – Correios de Portugal, S.A. ("CTT")

Pursuant to, and for the purposes of Article 16 of *Código dos Valores Mobiliários* (the Portuguese Securities Code) and Article 2 of *Regulamento da CMVM nº 5/2008* (Regulation 5/2008 of the CMVM), we hereby notify you that by virtue of the acquisition of discretionary voting rights by F&C Management Limited on 2 April 2015, corresponding to 370,621 shares representing 0.25% of the voting rights corresponding to the share capital in CTT, a qualified shareholding of 3,169,725 shares representing 2.11% of the voting rights corresponding to the share capital in CTT became imputable to F&C Asset Management plc.

The above-mentioned qualified shareholding is imputable to F&C Asset Management plc under Article 20(1)(b) of the Portuguese Securities Code, as the entity with whom each of F&C Management Limited, F&C Investment Business Limited and F&C Managers Limited are in a dominion relationship. Each of F&C Management Limited, F&C Investment Business Limited and F&C Managers Limited may exercise voting rights in shares in CTT as investment managers acting on behalf of a number of clients under discretionary investment mandates.

Furthermore, we hereby inform you that F&C Asset Management plc is under the dominion of BMO Global Asset Management (Europe) Limited which in turn is under the dominion of the Bank of Montreal.
