The increase was the result of on-exchange purchases on Euronext Lisbon totalling 133,367 equity swaps by J.P. Morgan Investment Management Inc., 331,442 equity swaps by JPMorgan Asset Management (UK) Limited and 49,304 equity swaps by JPMorgan Chase Bank, National Association.
